ABOUT AUTHORS

Daniel C. Dennett is Co-Director of the Centre for Cognitive Studies and Austin B. Fletcher Professor of Philosophy at Tufts University. He is the author of numerous publications in the philosophy of mind and cognitive science, including *Content & Consciousness*, *Consciousness Explained*, *Darwin's Dangerous Idea*, and, most recently, *Sweet Dreams*.

Lucia Foglia is Visiting Post-Doctoral Fellow UCSD at Università di Siena, Italy.

Rick Grush is Professor of Philosophy at the University of California in San Diego. He has widely published on topics in the philosophy of mind, cognitive science, and especially on mental representation.

Daniel D. Hutto is Professor of Philosophical Psychology at the University of Hertfordshire. His numerous publications on topics in the philosophy of mind include *Beyond Physicalism* (2000) and *Folk-Psychological Narratives* (2008). He is currently working on a co-authored book (with Erik Myin, Antwerp) entitled *Radicalizing Enactivism*.

Albert Newen is Professor of Philosophy at Ruhr-Universität Bochum (Germany). His focus is on the philosophy of mind and language. He has authored and edited numerous books and special issues of journals like *Consciousness & Cognition* and *Erkenntnis*, and published over 100 articles on topics from these areas.

Susan Oyama is Professor of Psychology, Emerita, at the John Jay College of Criminal Justice, and at The Graduate School and University Center, both of CUNY in New York City. Her main research interests are the concepts of development, evolution, and genetic information, as well as the nature/nurture opposition, and she has written extensively on Developmental Systems Theory.

John L. Protevi is Professor in the Department of French Studies at Louisiana State University in Baton Rouge. His books include Political Affect: Connecting the Social & the Somatic (2009), Political Physics: Deleuze, Derrida & the Body Politic (2001), and Time & Exteriority: Aristotle, Heidegger, Derrida (1994).

Philosophy of Consciousness and Cognition. Apart from this edition, he is currently editing a collection of papers on issues in the context of teleology, called *Zweck und Natur* (to appear in German in 2011).

Charles Siewert is Professor of Philosophy at Rice University, Houston. He has worked extensively on consciousness and intentionality, especially in his book *The Significance of Consciousness* (1998).

Evan Thompson is Professor of Philosophy at the University of Toronto, Canada. He works in the areas of cognitive science, phenomenology, and philosophy of mind. With Francisco Varela and Eleanor Rosch he co-authored The Embodied Mind: Cognitive Science and Human Experience (MIT Press, 1991). His book Mind in Life: Biology, Phenomenology, and the Sciences of Mind (Harvard University Press), to which this issue is devoted, was published in 2007. In 2010 it won the Edwin Ballard Prize awarded by the Center for Advanced Research in Phenomenology for an outstanding book in phenomenology. He is also the author of Colour Vision: A Study in Cognitive Science and the Philosophy of Perception (Routledge Press, 1995), and is co-editor of The Cambridge Handbook of Consciousness.

Robert Van Gulick is Professor of Philosophy and Director of the Cognitive Science Program at Syracuse University. He has published on a variety of topics in the philosophy of mind including consciousness, externalism, intentional content, reduction, emergence, and mental causation.

Michael Wheeler is a Professor of Philosophy at the University of Stirling. His primary research interests are in philosphy of science (especially cognitive science, psychology, biology, artificial intelligence, and artificial life) and philosophy of mind. He also works on Descartes and Heidegger and is currently completing a book called Extended X: Recarving the Biological and Cognitive Joints of Nature, covering issues surrounding the extended mind thesis.

Dan Zahavi is Director of the Danish National Research Foundation: Center for Subjectivity Research, and Professor of Philosophy at the University of Copenhagen.
