

Styleguide for references in the text and for the list of references

Bibliographical Formats

In the main text, please refer to all works in the following format:

(<Author's Last Name> <Year>, <Page Number>)

Example: (Hobbes 1651, 123)

An exception can be made for references to classical texts if they are quoted heavily. For example, write (KrV, <Page Number>) if you quote from Kant's *Kritik der reinen Vernunft*.

or to introduce abbreviations which can be used for references in the text:

KpV Kant, I. 1788. *Kritik der praktischen Vernunft*. Brandt / Klemme (eds.) 2003. Hamburg: Meiner.

KU Kant, I. 1790. *Kritik der Urteilskraft*. Klemme (ed.) 2006. Hamburg: Meiner.

MAN Kant, I. 1786. *Metaphysische Anfangsgründe der Naturwissenschaft*. Pollok (ed.) 1997. Hamburg: Meiner.
